

Key Investor Information

This document provides you with key investor information about this fund. It is not marketing material. The information is required by law to help you understand the nature and the risks of investing in this fund. You are advised to read it so you can make an informed decision about whether to invest.

QUADRANT (the "Sub-Fund") is a sub-fund of ATRIUM PORTFOLIO SICAV (the "Fund") Class A EUR (the "Class") - ISIN: LU0630472792

The Fund has appointed FundPartner Solutions (Europe) S.A. as management company.

Objectives and investment policy

The Sub-Fund's objective is to generate an average annual return equal to money market rates plus 3 percentage points, by offering an exposure to the following asset classes: cash, currencies, debt securities (government debt and corporate debt), equities and equity related securities and commodities. There is however no assurance that this return objective will be attained.

The Sub-Fund is actively managed. The money market rates (ESTER or SOFR30 Day Average, depending on the Sub-Fund's share class) are only used for the calculation of the performance fee (payable to the investment manager). The Sub-Fund does not intend to use the indices for performance comparison nor to track them. Due to the specificity of the indices, the degree of freedom is not relevant in this context.

The Sub-Fund will follow a dynamic asset allocation style of investment, with no fixed allocations to each investable asset class. The sub-Fund will mainly invest:

- directly in the securities/asset classes above-mentioned (except for commodities); and/or
- in undertakings for collective investment having as main objective to invest in the above-mentioned asset classes; and/or
- in any transferable securities (such as structured products) linked or offering an exposure to the performance of the above-mentioned asset classes, and Real Estate Investment Trusts (REITs) of closed-end type; and/or
- in financial derivative instruments having as underlying or offering an exposure to the above-mentioned asset classes.

The choice of investments will not be limited either by geographical area (including emerging markets) or by industry or in terms of currencies in which investments will be denominated. However, depending on financial market conditions, a particular focus can be placed in a single country (or some countries) and/or in a single currency and/or in a single economic sector.

For hedging and for any other purposes, the Sub-Fund may use all types

of financial derivative instruments traded on a regulated market and/or over-the-counter.

The Sub-Fund will normally be fully invested. However if the manager considers this to be in the best interest of the investors, the Sub-Fund may also hold up to 100% of its net assets in liquidity such as, among others, cash deposits, money market funds and money market instruments.

Dealing Frequency

The net asset value for the Class is calculated on each bank business day in Luxembourg ("the Calculation Day"). The cut-off time to submit subscriptions and/or redemptions orders is 4 p.m. Luxembourg time on the bank business day before the Calculation Day.

Distribution Policy

The Class is cumulative. No dividend will normally be distributed.

Currency

The currency of the Class is EUR.

Investment Horizon

This Sub-Fund may not be appropriate for investors who plan to withdraw their money within 3 years.

Minimum investment

The minimum initial subscription amount is EUR 100`000 and EUR 25`000 for any additional subscription.

Why is this Sub-Fund in this category?

By applying a dynamic asset allocation process between major asset classes, the Sub-Fund systematically monitors its market volatility which corresponds to the risk class 4, while aiming to outperform money market rates.

Are there any other particular Risks?

Risks that could affect fund performance and are not necessarily fully reflected in the risk and reward rating include:

- **Liquidity risks:** The Sub-Fund may invest part of its assets in less liquid securities. Those are securities that cannot easily be sold or exchanged for cash without a substantial loss in value. Those securities also cannot be sold quickly because of a lack of ready and willing investors or speculators to purchase the asset in certain market conditions.
- **Counterparty risks:** The Sub-Fund can conclude various transactions with contractual partners. If a contractual partner becomes insolvent, it can no longer or can only partly settle unpaid debts owed to the Sub-Fund.

- **Credit risks:** The Sub-Fund can invest a significant portion of its assets in debt securities. The issuers of these debt securities may become insolvent, which will mean that the securities will lose all or some of their value.

- **Risks from the use of derivatives:** The Sub-Fund may use financial derivatives instruments which will result in the Sub-Fund being leveraged and may result in material fluctuations in the value of the Sub-Fund. Leverage on certain types of transactions including derivatives may impair the sub-fund's liquidity, cause it to liquidate positions at unfavorable times or otherwise cause the Sub-Fund not to achieve its intended objective.

Leverage occurs when the economic exposure created by the use of derivatives is greater than the amount invested resulting in the Sub-Fund being exposed to a greater loss than the initial investment.

- **Operational risks:** The Sub-Fund may fall victim to fraud or criminal acts. It may suffer losses as a result of misunderstandings or mistakes by employees of the Management Company or by external third parties or may be damaged by external events, such as natural disasters.

The percentage of ongoing charges is based on the last year's expenses, ending 31/12/2021. This figure may vary from year to year. It excludes:

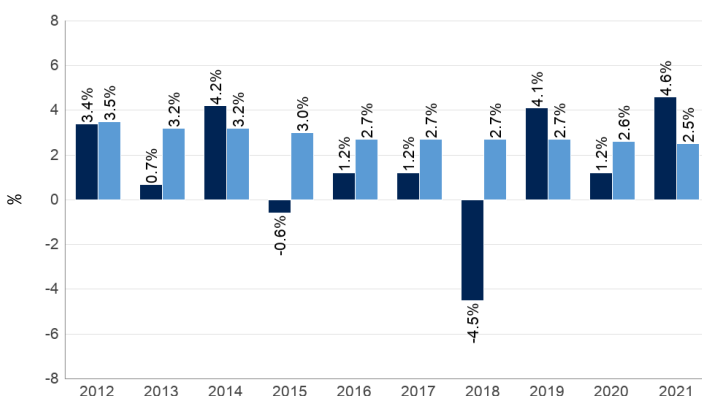
- Performance fees (if applicable)
- Portfolio transaction costs, except in the case of an entry/exit charge paid by the Sub-Fund when buying or selling units in another collective investment undertaking.

For the last financial year, the performance fee charged to the Class was 0.51% of the average annual net assets of the Class. This fee applied only to investments which redeemed with performances over the threshold.
