What is this product?

TYPE OF PRODUCT

The product is a Sub-Fund of ATRIUM PORTFOLIO SICAV, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

The Sub-Fund is established for an unlimited duration. However, the Directors may decide to close this product under certain circumstances.

Objectives and investment policy

The investment objective of the Sub-Fund is to increase the value of its investment and to earn income over the medium to long term (more than 5 years).

The Sub-Fund will mainly offer an exposure to the following asset classes:

- equities and equity related securities (including but not limited to ADR (American Depositary Receipt), GDR (Global Depositary Receipt), REITs (Real Estate Investment Trusts)), hereafter the "Equity Asset Class";
- debt securities of any type (government and corporate), including money market instruments, hereafter the "Debt Asset Class".

The proportion of assets devoted to each asset class varies over time. However, without being a constraint, the Investment Manager intends to:

- be neutral mix of 50% to the Equity Asset Class, and 50% to the Debt Asset Class;
- with an exposure to the Equity Asset Class varying between 40% and 60% of the Sub-Fund's net assets.

In order to achieve its objective, the Sub-Fund will mainly invest in undertakings for collective investment (UCIs) having as main objective to invest or grant an exposure to the above-mentioned securities/asset classes.

The choice of investments will neither be limited by geographical area (including emerging markets), economic sector, currencies in which investments will be denominated. However, depending on financial market conditions, a particular focus can be placed in a single country (or some countries) and/or in a single currency and/or in a single economic sector.

On an ancillary basis, the Sub-Fund may invest in any other type of eligible assets, such as equities and equity related securities, debt securities, money market instruments, structured products and cash.

If the Investment Manager considers it to be in the best interests of the shareholders, the Sub-Fund may hold up to 100% of its net assets in cash and cash equivalents (cash deposits, money market UCIs and money market instruments), on a temporary basis and for defensive purposes.

Derivatives For hedging purposes and for any other purposes, the Sub-Fund may use all type of financial derivative instruments traded on a regulated market and/or over-the-counter.

Benchmark The Sub-Fund is actively managed. The index ESTER index and SOFR30 Day Average index (depending on the Sub-Fund's share class) are only used for the calculation of the performance fee (payable to the investment manager). The Sub-Fund does not intend to use the indices for performance comparison nor to track them. Due to the specificity of the indices, the degree of freedom is not relevant in this context.

Dividend Policy This Class is cumulative. Dividend distributions are not planned.

Share Class Currency The currency of the Class is EUR.

The recommended holding period of this product is determined to allow sufficient time for this product to reach its objectives and avoiding short term market

The return of the product is determined using the Net Asset Value (the "NAV") calculated by the Central administration. This return depends mainly on the market value fluctuations of the underlying investments.

INTENDED RETAIL INVESTORS

The product is suitable for retail investors with limited knowledge of the underlying financial instruments and no financial industry experience. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and who wish to hold their investment over 5 years.

Switching Shareholders may apply for any shares of any sub-funds to be converted into shares of another sub-fund, provided that the conditions for accessing the target share class, type or sub-type are fulfilled with respect to this Sub-Fund, on the basis of their respective Net Asset Value calculated on the Valuation Day following receipt of the conversion request. The redemption and subscription costs connected with the conversion may be charged to the shareholder as indicated in the prospectus. What happens if FundPartner Solutions (Europe) S.A. is unable to pay out?

The Management Company is not making any payment to you in relation to this Sub-Fund and you would still be paid in case of a default from the Management Company.

The Sub-Fund's assets are held with a separate company, the Depositary, so the Sub-Fund's ability to pay out would not be affected by the insolvency of the Management Company. However, in the event of the Depositary's insolvency, or its delegates, the Sub-Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Sub-Fund. The Depositary will also be liable to the Sub-Fund or its investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations).

If the Sub-Fund is terminated or wound up, the assets will be liquidated and you will receive an appropriate share of any proceeds but you may lose part or all of your investment.

There is no compensation or guarantee scheme protecting you from a default of the Depositary.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
