What is this product?

TYPE OF PRODUCT

The product is a sub-fund of ATRIUM PORTFOLIO SICAV, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

TERM

The Sub-Fund is established for an unlimited duration. However, the Directors may decide to close this product under certain circumstances.

OBJECTIVES

Objectives and investment policy

The Sub-Fund objective is to generate an average annual return equal to money market rates plus 7pp, reflecting a long term historical risk premium. There is no assurance that this objective will be attained.

The Sub-Fund will mainly offer an exposure to equities and equity related securities (including convertible bonds, ADR (American Depositary Receipt), GDR (Global Depositary Receipt)) issued by companies worldwide. The Sub-Fund will mainly invest:

- directly in the securities mentioned in the previous paragraph; and/or
- in undertakings for collective investment having as main objective to invest in the above-mentioned securities;
- and/or in any transferable securities (such as structured products) linked or offering an exposure to the performance of the above-mentioned securities and Real Estate Investment Trusts (REITs) of closed-end type; and/or
- in financial derivative instruments having as underlying or offering an exposure to the above-mentioned securities.

Over time the Sub-Fund exposure to the world equity markets will vary from 50% to 150%. The choice of investments will not be limited either by geographical area (including emerging markets) or by industry or in terms of currencies in which investments will be denominated. However, depending on financial market conditions, a particular focus can be placed in a single country (or some countries) and/or in a single currency and/or in a single economic sector.

The Sub-Fund can also have an exposure to the following asset classes: currencies, debt securities (government debt and corporate debt) and commodities.

The Sub-Fund can be exposed to non-investment grade debt securities up to 10% of its net assets, including Distressed or Defaulted Securities.

In the event of downgrading in the credit ratings of a debt security, the Sub-Fund may, at the discretion of the Investment Manager, and in the best interests of the Shareholders, continue to hold those debt securities which have been downgraded provided that in any case the Sub-Fund's maximum exposure to Distressed and Defaulted Securities will be limited to a maximum of 10% of its net assets.

The Sub-Fund may also invest up to 10% of its net assets in Contingent Convertible Bonds.

Derivatives For hedging and for any other purposes, the Sub-Fund may use all types of financial derivative instruments traded on a regulated market and/or over-the-counter.

Benchmark The Sub-Fund is actively managed. The money market rates (ESTER or SOFR30 Day Average, depending on the Sub-Fund's share class) are only used for the calculation of the performance fee (payable to the investment manager).

Dividend Policy This Class is cumulative. Dividend distributions are not planned.

Share Class Currency The currency of the Class is USD.

The recommended holding period of this product is determined to allow sufficient time for this product to reach its objectives and avoiding short term market fluctuations.

The return of the product is determined using the Net Asset Value (the "NAV") calculated by FundPartner Solutions (Europe) S.A. (the "Administrative Agent"). This return depends mainly on the market value fluctuations of the underlying investments.

INTENDED RETAIL INVESTOR

The product is suitable for retail investors with limited knowledge of the underlying financial instruments and no financial industry experience. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and who wish to hold their investment over 7 years.

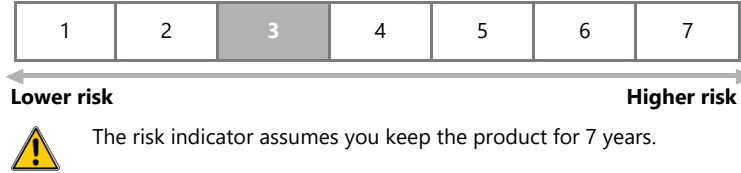

The redemption and subscription costs connected with the conversion may be charged to the shareholder as indicated in the prospectus. What are the risks and what could I get in return?

Risk indicator

What happens if FundPartner Solutions (Europe) S.A. is unable to pay out?

The Management Company is not making any payment to you in relation to the Sub-Fund and you would still be paid in case of a default from the Management Company.

The Sub-Fund's assets are held with a separate company, the Depositary, so the Sub-Fund's ability to pay out would not be affected by the insolvency of the Management Company. However, in the event of the Depositary's insolvency, or its delegates, the Sub-Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Sub-Fund. The Depositary will also be liable to the Sub-Fund or its investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations).

If the Sub-Fund is terminated or wound up, the assets will be liquidated and you will receive an appropriate share of any proceeds but you may lose part or all of your investment.

There is no compensation or guarantee scheme protecting you from a default of the Depositary.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take my money out early?

Recommended holding period (RHP): 7 years.
